How did SuperSND obtain your personal data?

SuperSND has obtained your data because you have provided this data to us.

What are your rights?

Under the European General Data Protection Regulation you have a number of rights with regard to your data and the processing thereof:

Access

You may access your personal information and make any necessary changes in your account. If you would like to see which personal data SuperSND has obtained about you, you may exercise your right of access by submitting a request to SuperSND.

Making changes

If you wish to make changes to the personal information that you have seen as a result of a request for access and you are unable to make the changes yourself in your account, you may request that SuperSND makes these changes for you. You may request that SuperSND modifies, corrects, supplements, erases or shields your information.

Restriction of processing of personal data

You also have the right, under certain conditions, to ask SuperSND to restrict the processing of your personal data.

Right to object

If processing of your data takes place on the grounds of 'legitimate interest' by SuperSND or a third party, you have the right to object to that processing.

Portability of data

You have the right to obtain your personal data from SuperSND. SuperSND will provide this in a structured and commonly used format, which can easily be opened using commonly used digital systems.

Withdrawing consent

When the legal basis for a particular processing is your explicit consent, you have the right to withdraw that consent. This does not affect past processing, but does mean that we will no longer be allowed to process this data in the future. It may also result in SuperSND no longer being able to provide you with certain services.

Response from SuperSND

A request can be sent to info@supersnd.com. SuperSND will comply with your request as soon as possible and in any case no later than one (1) month after SuperSND has received such a request. If SuperSND rejects your request, we will indicate in our reply why the request was rejected.

Recipients of your personal data

Your data may be transmitted to:

- Parties that are involved in the execution or fulfilment of an agreement between you and SuperSND

It is possible that SuperSND is required to submit your data to a third party, for example to fulfil a legal obligation.

Transfer to third countries or international organisations

It may be necessary, for instance for technical and operational reasons, to transfer your (personal) data to affiliates of SuperSND located outside the European Economic Area. Due to the possibility that the regulations in the area of privacy protection do not offer the same protection as within the European Economic Area, SuperSND will use the EU Model Clauses to protect your privacy as much as possible. If that is not possible, SuperSND will ask your consent to transfer your (personal) data to countries that do not maintain an adequate protection level. You may withdraw your consent at any time.

What are cookies and how does SuperSND use them?

Cookies are small pieces of (text) information that are sent to your browser when you visit the website of SuperSND and then stored on the hard disk or in the memory of your device. The cookies placed via SuperSND's website cannot damage your device or the files stored on it. With 'cookies', we also mean comparable techniques collecting information, such as device fingerprinting.
